**Parishioner - \$1,540.00** (does not include fee for music & wedding coordinator and altar servers) Registered 6 months prior to reserving the date for your wedding.

**Non Parishioner - \$1,700.00** (does not include fee for music & wedding coordinator and altar servers)

Total fee \$175 this fee reflects eight hours spent planning and executing your wedding. (checks made payable to Maria Donovan 2 weeks before or the night of your rehearsal)

**Programs** - When picking your Readings from the Together for Life book you need the 1<sup>st</sup> Reading from the Old Testament the 2<sup>nd</sup> Reading from the New Testament. The priest will pick the Gospel Reading unless you have an outside priest you want to check with him regarding the Gospel Reading. You pick the Responsorial Psalm and Prayer of the Faithful enclosed is a sample and feel free to use this one.

**Your final appointment** will be set up about 3 months before your wedding date we will e-mail you . At that time Deacon Joe Carr will conduct the PNI (Pre Nuptial Investigation) it is a series of the same questions asked of the bride and the groom separately. Below is what you will need to bring to this appointment.

1. A recent copy of your baptismal certificate, not the one from your original baptism. You can request a copy of the baptismal certificate from the rectory of the church you were baptized in. (If you were baptized at St. Matts, SS Cosmas or St. Mary's we already have that information)

2. Your Pre-cana certificate

3. 4 Testimony Letters 2 for the bride and 2 for the groom.

These letters should read:

Dear Father Heron: To my knowledge (Name)\_\_\_\_\_ have never been married before. Signed and dated by your Mom, Dad, Brother, Sister, Aunt, Uncle, Grandparent. The statement can be mailed or emailed to [stmatthewrectory@verizon.net](mailto:stmatthewrectory@verizon.net) or St. Matthew Church – 219 Fayette St., Conshohocken, PA 19428.

4. The balance of your deposit \$1,040.00 or non-parishioner \$1,200.00

5. The altar server fee - \$30 cash \$15 for each altar server (you can give this to Maria Donovan at your rehearsal)

6. Your Marriage License – you can drop off your license the week of your wedding before Thursday if you do not have it by this appointment. We need this document so it is filled out and Father can just sign it and give it to you the day of the Wedding.
